### **National President's Report**

Our Association achieved key objectives over the course of the year, with our activity increasing across the board in all areas:

- We convened our second National Summit on Cultural Diversity with the theme "Towards a more Inclusive Future";
- We held a record total of 57 events nationally and across all Branches over the 2021 calendar year, compared with 32 events in 2020, 37 events in 2019, and 21 events in 2018 (excluding the AGMs and Annual Branch Meetings);
- We further developed our Secretariat and Governance Portfolio and started a Steering, Policy, Advocacy & News Media Portfolio in recognition of the emergence of an operational management function;
- We have continued our Student Engagement Portfolio that has built student memberships;
- We continue to grow internal connectivity across the organisation using Basecamp online management and the Padlet platform to supplement communications around issues, opportunities and events;
- We have recently inaugurated AALA branches in the ACT, SA, Tasmania and the NT, marking eight branches across all states and territories: Victoria (2013), NSW (2015), WA (2016), Queensland (2017), SA (2020), ACT (2020), Tasmania (2020) and NT (2021);
- We are offering more and varied benefits to members at all levels and will introduce this as our Association consolidates its recent strong growth over the past two years; and
- We maintained our communications and programs mostly on a virtual space and have re-introduced in-person meetings and events in line with public health orders.

#### The Second National Cultural Diversity Summit

This was held as a virtual online event with a record 600+ registrants. The organisation of this event headed by Queensland Branch President Anand Shah involved an enormous contribution from many of us across Australia.

The Summit examined how cultural diversity can advance with wider inclusion:

 how the process of equality and its effect on women of colour galvanises the process of change;

- how wider civic responsibilities have profoundly shifted though the developments in parallel professions; and
- where current D & I programs are taking us as a process of change.

This signature event further evolves our voice in the cultural diversity space, and has triggered a number of advocacy projects.

#### **AALA Patrons**

We have an extraordinary and inspiring array of patrons. They reflect our emerging relationship to the profession and public arena.

- Our National Patron, the Hon Diana Bryant AO QC, was appointed in April 2021;
- Our former National Patron from 2013-2020, Michael Kirby AC CMG, now serves as our Emeritus Patron; and
- Our International Patron, the Rt Hon Lord Justice Rabinder Singh, judge of the Court of Appeal of England and Wales, was appointed in July 2021 for a three-year term.

We have also appointed Branch Patrons in 2021 as follows:

- The Hon Gareth Evans AC QC is our Victorian Branch Patron, who was appointed in July 2021;
- Katrina Rathie is our NSW Branch Patron, appointed in July 2021; and
- His Honour Anthony Gett, Deputy Chief Magistrate of Queensland, is our Queensland Branch Patron, appointed in November 2021.

These new Branch Patrons are in addition to our existing Western Australian Branch Patron, the Hon Robert French AC, who was appointed in 2019.

The breath and experience of our Patrons underlines our values and our future direction. We look forward to succeeding years with their support of our cultural diversity work and advocacy.

#### Partnerships and Sponsorship

We formed a national portfolio to discuss and develop a comprehensive options paper and sponsor model. The discussion was robust and rigorous. AALA commends the amazing committee work headed by Kelvin Ng.

As a result of COVID-19, it has been an effort to maintain the same support from our sponsors. The National Summit has helped to stem this concern by attracting new and further sponsors from various Bar Associations and Law Societies.



This new policy and the recent experiences from hosting National events and maintaining specific State events will shape our engagement with law firms and providers to the industry.

We are incorporating this new policy as resolved in October 2021 and are developing a sponsorship prospectus that we are aiming to send to prospective sponsors and partners in early 2022.

#### Membership

AALA maintained its membership base that numbered almost 1,200 at close of financial year 2020-2021, a record for AALA. Our membership is proactive. We encourage and shape our association around internal connectivity. We continue to have good responses when AALA posts up vacancies for various appointed volunteer officer positions in our various committee and portfolio teams. We continue to conduct member and event surveys. Such feedback is instrumental to delivering what members need.

AALA's main asset is its people with their hopes and their values. We have over 100 members volunteering their time and energy for developing and producing policy, discussing and planning projects, running events and communicating at all levels in social media and media. Our meetings reflect interdependency and democratic leadership and decision making and a grassroots approach. The tenor of our National and State meetings leans towards innovation, support, problem solving, policy and capacity building. AALA is proud of its collegiality and positivity in its processes.

#### Succession

I joined AALA in 2015 and will be retiring at this AGM. I have served AALA as NSW President / on National Executive Committee for three years and as National President for three years. I have been immensely and deeply privileged to play a leading role over these six years as AALA's longest serving President.

I appreciate and pay tribute to the contributions made by colleagues at all levels under challenging pressure. A number of them are also retiring along with myself. Our Association has impressive human resources for leadership responsibilities. I am truly pleased that the incoming succession team has the skills and strengths to enable AALA's vision and strategies as it evolves with changing times.

### **National Vice-President's Report**

The year started out with hope of seeing a pandemic-free or COVID-safe world but those hopes were dashed quickly as we realised that the pandemic is here to stay for some time. Last year we had adapted to the changing isolated world by moving online which also assisted us in creating a more integrated national model. We continued along the same lines this year but with some States that had fewer and shorter restrictions being able to meet and have events in person.

The Victorian, NSW and ACT Branches were particularly impacted; however the recent easing of restrictions has seen an enthusiastic take-up of in-person events.

We were still able to achieve phenomenal growth and some major milestones, including now having Branches in every State and Territory. The President's Report highlights other significant events and projects undertaken since the last AGM.

In my report I will focus on three areas, Marketing and Social Media, News Media, the National Digital Events Series and Branch Formation.

#### Marketing, Social Media and News Media

Building from the 2020 rebranding, 2021 was a strong year for marketing and social media. The two portfolio goals were achieved:

- Train branches to be self-sufficient: This
  involved numerous training sessions
  with selected representatives from each
  Branch. The training sessions and
  recorded tutorials focused on how to edit
  the website, send emails and post news
  / blogs.
- 2. Launch of the new AALA Website: After years of discussion and months of planning and designing, the new website has been launched. Working with EMD Digital, the new website retains the Wild Apricot backend and delivers a new front end user experience. While we still have areas to improve on, the website has been a game changer for our Members and attracting new Members. Special thanks to Marija Gurlica, Convenor of the Marketing and Social Media Portfolio, who led the AALA consultation and design.

In the period of lockdowns and isolation, marketing and social media have never been so important. AALA has engaged with our members and community online, keeping everyone connected and ensuring AALA as a relevant, helpful and beneficial organisation.

Our news media engagement has also been strongly supporting our advocacy pillar, with seven media releases made this year in relation to issues impacting our Asian Australian communities and the legal sector, resulting in three media pick-ups by Lawyers Weekly. Of note were our media statements made in relation to International Women's Day, ANZAC Day reflection, the launch of the William Ah Ket Scholarship for the fourth year running, developments in Afghanistan, issues of racism in the workplace, the appointment of the Rt Hon Lord Justice Rabinder Singh of the Court of Appeal of England and Wales as our first international patron and the appointment of the Hon Justice Hament Dhanji SC to the NSW Supreme Court.

We were also recently featured in a Lawyers Weekly article where our National President Kingsley and I discussed the imperative of cultural diversity in the legal profession.

#### **National Digital Events Series**

Our National Digital Events Series, born out of COVID has been running successfully since last year and has proven to be a good platform to engage nationally with our membership.

The series was mainly delivered via AALA's Zoom platform unless it was run in partnership with another association or on a firm or sponsor platform. AALA promoted and advertised the sessions on the AALA website and social media and through its partners.

Some of the interesting and insightful events that were run as part of the Program included:

- Trends in Climate Litigation, together with National Environmental Law Association run by our National Secretary Matt Floro;
- AALA Foreign Qualified Lawyers, Contract Drafting Workshop by Sue Tomat of GumLeafGreen; and
- Career Workshop Series Interview Skills.

We will continue to engage through our National Digital Events Series going forward, tapping on to speakers from across the country and globally and reaching out to audiences more widely.

#### **Branch Formation**

We are very pleased to report that we are now a truly National organisation. Following the 2020 AGM, the only two Branches that were left to be



established were the Tasmanian and Northern Territory branches and both these Branches have now been successfully established and running. The Tasmanian Branch was formed late last year under the leadership of Jessica Sabapathy as President and Bunewat Keo as Secretary. Both of them did a great job in setting up the Branch but due to other pressing commitments are unable to continue. We have received nominations for the new Tasmanian Branch Committee and will announce them in due course.

The Northern Territory Branch was formally established at our October National Executive Committee meeting and we are very pleased to see the Branch led by Lyma Nguyen as President and Jacinta Mu as Secretary. We wish them all the very best for getting the ball rolling in NT.

Being a nationally-run non-profit volunteer organisation, we are conscious of having our governance reflective of that and are investigating registering as a charity with the Australian Charities and Not-for-profit Commission.

I look forward with anticipation to what the new year brings for us. I know that we will continue building on our work, now as a national organisation. With the easing of restrictions, I am hopeful that we will be able to see each other face to face more often and that we have much to celebrate when we meet again next year.

### **National Secretary's Report**

2021 has been another incredibly challenging year with continuing lockdowns in various states amidst the strains (and/or joys!?) of working remotely. AALA has tackled the year with strength and courage, launching our inaugural TAS and NT Branches, obtaining the patronages of the Hon Diana Bryant AO QC and Sir Rabinder Singh, and holding our second National Cultural Diversity Summit with a record 600+ registrants – our largest event ever.

AALA continues to be a high-achieving, progressive organisation dedicated to advancing cultural diversity in the legal profession. I have been privileged to serve with the exceptional Kingsley Liu, Molina Asthana, Nai Yan Yeap, our Executive Committee and Branch Committees. It is a large responsibility to have oversight of administration, operations governance and I thank my AALA colleagues for their generous support, trust and goodwill. I particularly thank Kingsley for his mentorship, friendship and wise counsel over more than five years in my time in the Association. He has led AALA with great empathy, energy and vision and his legacy will be everlasting.

#### William Ah Ket Scholarship

Jenny Si and William Lye OAM QC expertly coconvened the William Ah Ket Scholarship this year, generously sponsored by Maddocks. The launch in June featured a keynote address by the Hon Chief Justice Anne Ferguson of the Supreme Court of Victoria.

The winner of the Scholarship, Sarah Webster, was announced at a celebratory dinner featuring the recently appointed Hon Justice Hament

#### **Student Engagement**

Kelvin and his team held a highly successful Career Workshop Series, co-hosted an International Students Moot with the Global Law Students' Association, convened multiple panel discussions, and partnered with numerous university law faculties and student societies, including the Australian Law Students' Association.

### **National Treasurer's Report**

In 2017, our Western Australian Branch was newly inaugurated; soon after, the Queensland Branch joined us, and AALA had doubled from two Branches to four. Now, in 2021, we have a Branch in all eight states and territories, with the inauguration of the Northern Territory Branch this year. We have become a truly national organisation and can better reach and serve even more of the community.

In 2017/2018, we had approximately 500 members, mostly in four states. Now, we are in excess of 1,000, with members all over Australia. These are just a couple of the subcommittees supporting AALA to become a leading organisation for cultural diversity in the law, and I hope we can continue to grow these portfolios. I'm so proud of how the Executive Committee, and all the other subcommittees, have improved the way we run behind the scenes and in the background.

### **New South Wales Branch Report**

For 2021, the NSW Membership elected a new leadership team welcoming Branch President, Marija Gurlica and Branch Secretary, David Bobby Chong. In addition to these Branch roles, Marija also sat as National Marketing and Social Media Convenor and David was Secretary of the National ASG Subcommittee. The Committee welcomed new faces and enjoyed the continued support of valuable Members, and operated three sub-committees:

- 1. Student Sub-Committee;
- 2. Data and Policy Sub-Committee; and
- Foreign Qualified Lawyers Sub-Committee.

The Student Sub-Committee for 2021 was chaired by Committee Member, Chelsea Wu. The objective of the NSW Student Subcommittee is to engage with universities and our student Members. In 2021, the Student Subcommittee worked with the National Executive to launch the NSW Mentoring Program, connecting students and junior practitioners to the wider legal profession.

The Data and Policy Subcommittee was chaired by Committee Member, Lee-May Saw. The objective of the NSW Data and Policy Subcommittee is to advocate for and work on projects that promote the collection of data that is required for a meaningful insight into cultural diversity. The just collection of and equitable access to such data helps form meaningful policies and funding for genuine cultural diversity and access to the law. In 2021, the NSW Data and Policy Subcommittee has worked with the National Executive to submit a paper to the Australian Law Reform Commission in its Review of Judicial Impartiality Inquiry 2021. The NSW Data and Policy Subcommittee continue to work with bodies such as the NSW Law Society and NSW Bar Association to expand its work and advocacy.

The Foreign Qualified Lawyers Subcommittee was chaired by Committee Member, Kripi Bhatt. The NSW Foreign Qualified Lawyers Subcommittee (FQL Subcommittee) is unique as it operates nationally. Established in 2020 by foreign qualified lawyers, for foreign qualified lawyers, the FQL Subcommittee meet regularly to provide a space of support to foreign qualified lawyers. In 2021, the FQL Subcommittee has hosted numerous events, including a drafting workshop with Sue Tomat and has launched the FQL Frequently Asked Questions Guide.

Two core objectives were agreed on by the NSW Committee for 2021:

- to begin charging fees for events (strengthening the distinction between benefits received by Members and non-Members); and
- increase the value of NSW Members, including the number of opportunities available for them.

These two objectives are intertwined. In relation to the charging of fees, the FQL Sub-Committee hosted two events that required registration and a fee, and the NSW Committee hosted two social events that also required registration and a fee. While we intended to have more fee-events, the NSW Committee acknowledged the difficultly caused by the pandemic and our key value of inclusiveness. Inclusiveness, being access to social and networking opportunities that did not discriminate based on postcode (online events) or socioeconomic means (free events) was crucial during the pandemic. The NSW Committee wanted to keep our community connected. In relation to increasing the value of Members, each Sub-Committee witnessed a remarkable level of engagement throughout the year. Building on these milestones will be a key focus for the 2022 NSW Committee.

In 2021, the NSW Branch also welcomed the appointment of our inaugural State Branch Patron, Katrina Rathie. Elected from a shortlist by the NSW Committee, Ms Rathie will work closely with the NSW Committee throughout the new year to build the NSW impact and outreach. The NSW Committee and Ms Rathie share a strong passion for intersectional diversity and inclusiveness.

A significant development in 2021 was that Members elected the first female NSW Branch President and this President, Marija was also able to take maternity leave from her duties. The collegial network of AALA and the clear, grassroots inspired, 'all-hands in' structure and attitude of the NSW Committee made this possible. This is a testament to the values that the NSW Committee holds.

NSW, home to some of the leading business districts of Australia, was significantly impacted by the pandemic. Our Committee and Members witnessed this first hand - racism, shifts in how we work and live, pay-cuts, job-losses, cancelled and rescheduled events such as weddings and admissions.



On a personal note, the year has taken a toll on the Committee. While it has been challenging, it has bound us together and motivated us to deliver purposeful opportunities to our Members. I know that this same drive will continue to shape the Committee's intentions and actions for the new year, strengthening our suite of services and outreach. The 2021 AALA Mentoring Program (for Queensland mentors and mentees) was launched on 5 May at a well-attended event at Herbert Smith Freehills. The guest speaker was Deputy Chief Magistrate Gett. ### **South Australia Branch Report**

The South Australian (**SA**) Branch of AALA has had a big and wonderful first year in 2021.

The SA Branch was formed in October 2020 and started its existence with 3 members on the committee. Faced with the challenges of 1) establishing the SA Branch and 2) the uncertainties arising from COVID-19, the SA Committee began its first year with a sense of nervous anticipation and excitement.

Since that time, with teamwork and a focus on good food and mentorship, the SA Committee has ended the year with 7 members, grew the SA membership base to almost 70 and managed to hold nearly one event per month in 2021.

#### The SA Branch's first year

- 25 February 2021: The official launch of the SA Branch on 25 February 2021 was held at Kosho in North Adelaide. The keynote speaker was Magistrate Jayanthi McGrath (of the Magistrates Court of South Australia). Magistrate McGrath held everyone's attention as she recounted her early days as a junior solicitor and the progression of her career, culminating in her current role. Many attendees stayed well into the night, beyond the official close of the event and enjoyed all the good food.
- 24 March 2021: In conjunction with the College of Law, we hosted a mentoring panel discussion featuring lawyers of Asian heritage in diverse fields of law. Magistrate McGrath chaired this panel discussion and described how important effective mentoring is at all levels. The panelists discussed various topics including the pros and cons of following a mentor to a new firm and what they have found to be effective mentoring.
- 28 April 2021: The national 2021 AALA Mentoring Program was formally launched in SA at Sparkke on Whitmore Square with a keynote speaker, former District Court Judge, the Honourable Steven Millsteed QC and the assistance of red packets containing questions for mentors and mentees to help start their mentoring relationship. In SA, 30 AALA members sought a mentor and almost 20 people volunteered to be mentors.
- **24 June 2021**: Nathan Schwarz (Director and Founder of Black Box Restructuring and Forensic Accounting) delivered to our members a CPD on what insolvency practitioners look for in a lawyer, and how the sharing of knowledge between

insolvency practitioners and lawyers can provide real gains for clients.

- 19 September 2021: As part of the 2021 National Cultural Diversity Summit, an after party was held at 1/3 by NNQ where a panel of speakers spoke to us about being more than a lawyer. It was fascinating to hear about the different views of each panel member (comprising His Honour Judge Soulio of the District Court, Kate Bickford, Partner at HWL Ebsworth Lawyers and Thuan Nguyen, Legal Services Commission) as to what being more than a lawyer means to them. Again, many attendees stayed well into the night, beyond the official close of the event and enjoyed all the good food.
- 28 October 2021: As part of the formal conclusion of the 2021 AALA Mentoring Program we hosted an event at where it began, in a "full circle", at Sparkke on Whitmore Square (again with the assistance of red packets containing questions for mentors and mentees to help reflect on their time in the Mentoring Program). We heard from Chris Kwong, Executive Adviser to the CEO of Red Cross Australia speak on his experiences as a mentee and how it has helped him going forward.
- **8 December 2021:** We intended to hold in August a cocktail function at Parliament House to be hosted by the Honourable Zoe Bettison MP (State Member for Ramsay) who is the Shadow Minister for Multicultural Affairs (amongst her other portfolios) however, due to restrictions imposed by COVID-19, this event has been deferred to 8 December 2021 to end our first year.

#### What next for the SA Branch?

The first year of the SA Branch has certainly been a learning experience, but it is clear that there is a need for an organisation like AALA in SA, as evidenced by the huge support and feedback we have received from our members (including that we have held the best networking event that they have ever attended!). Such support and feedback has buoyed us to continue to cement AALA's presence in SA.

I am honoured to be the inaugural President of the SA Branch and acknowledge and thank the tireless effort and work of each member of the SA Committee, especially the inaugural SA Secretary, Brian Vuong, during the year. Without each committee member, SA would not have been able to experience the success that it did during the year. I also thank all our SA members,

#### Victorian Patron
